Strong-Arm Robbery - On March 2 at 11:37AM, officers responded to Lindsay Chrysler Dodge Jeep Ram located at 8100 Centreville Rd. in Manassas (20111) to investigate a robbery. The investigation revealed an unknown man struck an employee and took the keys to a grey 2022 BMW M3 before driving the vehicle out of the parking lot. No injuries were reported. The suspect was described as black male, bald with a muscular build wearing dark-colored clothing.

Arrests

Malicious Wounding [Domestic] - On March 1 at 9:39PM, officers responded to investigate a domestic dispute that was reported to have occurred at a residence located in the 10200 block of Farragut Ct. in Manassas (20109) on February 28. The investigation revealed the victim, a 29-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused assaulted the victim and strangled her with a shoelace before the parties separated. Non-life threatening injuries were reported. The following day, the accused attempted to set fire to the home before leaving the area. The accused eventually returned to the residence where he was detained by Fire Marshals without incident. Following the investigation, the accused, identified as Jose Adony **AREVALO GARAY**, was arrested.

Assault and Battery on a Law Enforcement Officer [LEO] – On March 2 at 10:55PM, officers in the 13100 block of Thornton Dr. in Gainesville (20155) attempted to detain an intoxicated driver, later identified as the accused. The investigation revealed the victim, a 39-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused brandished a knife towards the victim before the parties separated. When officers arrived at the residence, the accused pushed an officer after initially preventing the officers from making entry into the home. No injuries were reported. Following the investigation, the accused, identified as Diego Manuel **VEGA**, was arrested.
