Incidents

Abduction [Domestic] - On March 3 at 7:57PM, officers responded to the Somerset Pointe Apartments located in the 14700 block of Soapstone Dr in Gainesville (20155) to investigate a domestic dispute. The investigation revealed the victim, a 55-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim and threw her to the ground. When the victim attempted to call emergency services, the accused forcibly took her phone. The victim then attempted to go to a neighbor's apartment where she was grabbed again by the accused and pulled back towards her



apartment. The neighbor was able to intervene to separate the parties and contact the police. Minor injuries were reported. The accused left the area prior to officers arriving at the scene. A police K-9 searched the area for the accused who was not located. Following the investigation, officers obtained arrest warrants for the accused, identified as Brady Taylor KREILSER.


Residential Burglary – On March 3 at 10:47PM, officers responded to the Woodburn Apartments located in the 11200 block of Golden Leaf Cir in Manassas (20109) to investigate a burglary. The investigation revealed an unknown man was located inside the residence who immediately left through a window. A police K-9 searched the area for the suspect who was not located. No property was reported missing.

Arrests

Felony Child Neglect – On March 2 at 7:20PM, officers responded to investigate a child neglect that was reported to have occurred at a residence located in the 16700 block of Blackjack Oak Ln in Woodbridge (22191) earlier that evening. The investigation revealed the victim, a two-year-old girl, was receiving care at an area hospital after possibly ingesting a suspected narcotic that was in the possession of the child's mother, identified as the accused, while at the home. The child was treated at an area hospital and is expected to recover. Following the investigation, the accused, identified as Keona **OWENS**, was arrested.

Sexual Assault Investigation - On March 2 at 1:18AM, detectives concluded an investigation into a sexual assault that was reported to have occurred at a residence located in the 2200 block of W. Longview Dr. in Woodbridge (22191) on February 8. The investigation revealed the victim, who is under the age of 18, was sexually assaulted during a recorded encounter by multiple individuals at the residence of an acquaintance. The victim eventually left the home and went to a local business where an employee assisted her in contacting the police. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, detectives obtained arrest warrants for the three men involved in the incident, identified as the accused suspects below. All three men were arrested between February 13 and March 2.

Alixon **MOTA DE PAULA**, 18, of 1901 Inglebrook Dr. in Woodbridge Charged with *rape, forcible sodomy*, and *production of child pornography*
