Abduction [Domestic] [Previously Released] - On March 3 at 7:57PM, officers responded to the Somerset Pointe Apartments located in the 14700 block of Soapstone Dr in Gainesville (20155) to investigate a domestic dispute. The investigation revealed the victim, a 55-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim and threw her to the ground. When the victim attempted to call emergency services, the accused forcibly took her phone. The victim then attempted to go to a neighbor's apartment where she was grabbed again by the accused and pulled back towards her apartment. The neighbor was able to intervene to separate the parties and contact the police. Minor injuries were reported. The accused left the area prior to officers arriving at the scene. A police K-9 searched the area for the accused who was not located. Following the investigation, officers obtained arrest warrants for the accused, identified as Brady Taylor **KREILSER**.

Strong-Arm Robbery – On March 6 at 1:41AM, officers responded to the 13000 block of Qualls Ln. in Woodbridge (22193) to investigate a robbery. The investigation revealed the victim, a 27-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim and forcefully took her phone. The victim was eventually able to get her phone back before the accused left the area. The victim reported non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Salman **RAHMAN**. Attempts to locate the accused have been unsuccessful.



Abduction | Strangulation [Domestic] – On March 5 at 11:12PM, officers responded to a residence located in the 12800 block of Valleywood Dr in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 39-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim's neck. A short time later, the accused prevented the victim from leaving a room before assaulting her. The parties eventually separated, and the police were contacted. Non-life threatening injuries were reported. Following the investigation, the accused, identified as Mikael Lee **THOMASON**, was arrested.

Malicious Wounding – On March 5 at 11:55AM, officers responded to a residence located in the 19000 block of Queen Dr. in Triangle (22172) to investigate an assault. The investigation revealed the victim, a 62-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck and kicked the victim multiple times before the parties separated. The victim was transported to an area hospital with non-life threatening injuries. Following the investigation, the accused, identified as Jose Antonio **RIVERA**, was arrested.




