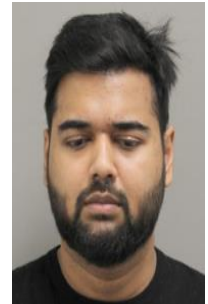
Strong-Arm Robbery *ARREST – On March 6, the suspect, identified as Salman **RAHMAN**, who was sought in connection to the robbery that was reported to have occurred in the 13000 block of Qualls Ln. in Woodbridge (22193) earlier that day, was arrested.

Strong-Arm Robbery [Previously Released] – On March 6 at 1:41AM, officers responded to the 13000 block of Qualls Ln. in Woodbridge (22193) to investigate a robbery. The investigation revealed the victim, a 27-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim and forcefully took her phone. The victim was eventually able to get her phone back before the accused left the area. The victim reported non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Salman **RAHMAN**. Attempts to locate the accused have been unsuccessful.

Fatal Crash Investigation – On March 7 at 5:46AM, crash investigators responded to the area of Dumfries Rd. near Old Stage Rd. in Dumfries (22025) to investigate a crash. The investigation revealed a 56-year-old man was attempting to catch a loose dog running in traffic. After catching the dog, the man was walking back across Dumfries Rd when he was struck by a 2022 Ram ProMaster van that was traveling westbound approaching Old Stage Rd. At the time of the collision, the man was wearing dark-colored clothing and walking in an unlit area of the roadway, crossing outside of a crosswalk. An officer and Good Samaritan provided first aid until the man was transported to an area hospital where he died from injuries sustained in the collision. The dog, a 2-year-old mixed Dalmatian/Pointer, was located and treated for injuries before being released to the owner. **Crash investigators are asking anyone who may have witnessed this crash to contact police.**

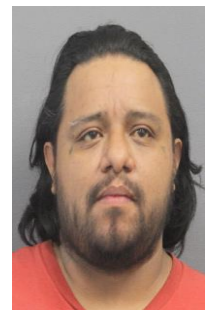

Assault & Battery on a Law Enforcement Officer [LEO] – On March 6 at 8:42PM, officers responded to the Cheesecake Factory inside Potomac Mills located at 2708 Potomac Mills Cl. in Woodbridge (22192) to investigate an intoxicated individual. When officers arrived at the location, the accused refused to leave the business. When officers attempted to detain the accused, he actively resisted and struck the officer before being detained without further incident. No injuries were reported. Following the investigation, the accused, identified as Wilmar Anderson **RENDON**, was arrested.

Strong-Arm Robbery – On February 26 at 11:10 AM, the School Resource Officer assigned to Gar-Field High School located at 14000 Smoketown Rd. in Woodbridge (22192) began an investigation into a robbery that was reported to have occurred on February 20. The investigation revealed the victim, a 17-year-old male student, was approached outside the school by three other male students. During the encounter, the three accused struck the victim causing him to fall to the ground where they took his shoes and left the area. Non-life threatening injuries were reported. Following the investigation, the three accused, identified as two **15-year-old male juveniles** and one **16-year-old male juvenile**, were charged.
