Incidents

Armed Robbery - On March 7 at 2:40AM, officers responded to the 7-Eleven located at 17360 Dumfries Rd. in Dumfries (22026) to investigate a robbery. The investigation revealed an unknown man brandished a firearm and took money from the cash register before leaving the area. No injuries were reported. Officers and a police K-9 searched the area for the suspect who was not located. An undisclosed amount of money was reported missing.

Reckless Handling of a Firearm – On March 9 at 6:45PM, officers responded to The Landings at Markham's Grant Apartments located in the 15400 block of Mendoza Ln. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed an unknown man fired multiple rounds towards a dark-colored SUV parked on Tassia Ln. The SUV left the area followed by the suspect in a sedan. No injuries or property damage were reported. Shell casings were located in the parking lot.

A black male, early 20s, approximately 6'0" with a thin build and shoulder length dreadlocks

Attempted Armed Robbery – On March 7 at 10:14PM, officers responded to the 12700 block of Cara Dr. in Woodbridge (22192) to investigate an attempted robbery. The investigation revealed the victim, a 30-year-old man, was inside his vehicle when he was approached by a masked man brandishing a firearm. During the encounter, the victim began to drive away as the suspect got into an Audi A4 and attempted to prevent the victim from leaving. The vehicles collided before the victim was able to leave the area and contact the police. A short time later, the unoccupied Audi A4 was located in Fairfax. No injuries were reported. There is no further suspect description at this time.

Commercial Burglary – On March 10 at 3:57AM, officers responded to Tropical Smoothie located at 2966 Prince William Pkwy in Woodbridge (22192) to investigate a burglary. The investigation revealed forced entry was made into the business at approximately 2:07AM. Cameras showed an unknown man broke out the front glass door and entered the business where he then damaged cash registers before leaving. No property was reported missing. There is no further suspect description at this time.
