Abduction | Strangulation | Felony Child Neglect [Domestic] [Previously Released] - On February 14 at 11:16PM, officers responded to a residence located in the 7400 block of Brunson Cir in Gainesville (20155) to investigate a domestic. The investigation revealed the victim, a 27-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim in the face before grabbing her neck. At one point, the accused prevented the victim from contacting emergency services by taking her phone. The accused then took the victim's vehicle without permission. When the victim attempted to stop the accused, he drove off in a reckless manner with the victim and their young child unrestrained. The parties eventually separated, and the police were contacted. Non-life threatening injuries were reported by the victim. The child was unharmed. Following the investigation, officers obtained arrest warrants for the accused, identified as Naim ARRAK. Attempts to locate the accused have been unsuccessful.
