Incidents

Death Investigation – On March 14 at 10:57AM, officers responded to Bristow Station Battlefield Heritage Park located at 10708 Bristow Rd. in Bristow (20136) to investigate a death. The investigation revealed a 65year-old man was on the walking trails when he collapsed, possibly due to a medical emergency. The man was located unconscious by a passerby and pronounced deceased on scene. No foul play is suspected with the death. More information will be released as necessary.

Armed Robbery – On March 16 at 11:13PM, officers responded to a residence located in the 1200 block of Easy St. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 21-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation. During the encounter, the accused was holding a firearm and took the victim's phone before leaving the residence. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Alex Daniel **GARCIA-GARCIA.** Attempts to locate the accused have been unsuccessful.

Strong-Arm Robbery – On March 16 at 5:52PM, officers responded to Cloverdale Park located at 15150 Cloverdale Rd in Woodbridge (22193) to investigate a robbery. The investigation revealed the victims, a 13-year-old male juvenile and a 15-year-old male juvenile, were approached by a group of juvenile acquaintances near the basketball courts. During the encounter, an altercation ensued before a phone was taken. The phone was later recovered and the parties dispersed before the victims went to a nearby home where police were contacted. No injuries were reported.

Residential Burglary – On March 16 at 9:16AM, officers responded to a residence located in the 3900 block of Cressida Pl. in Woodbridge (22192) to investigate a burglary. The investigation revealed forced entry was made into the home through an unsecured window. Camera footage revealed an unknown man entered the residence while two unknown women waited outside. A rear fence was also found damaged. No property was reported missing. No further suspect descriptions are available at this time.

Arrests

Armed Robbery – On March 16 at 10:24PM, officers responded to Walgreens located at 14095 Richmond Hwy. in Woodbridge (22191) to investigate a robbery. The investigation revealed an employee of the store approached a man, later identified as Dwayne Andre **BOLDEN**, for shoplifting. During the encounter, **BOLDEN** threatened the employee, implying he was armed. Officers located **BOLDEN** getting into a vehicle on Bel Air Rd. and then fled on foot. Officers eventually detained **BOLDEN** without further incident. Additional officers also followed the vehicle which crashed at low speed into a fence post causing minor damage. The driver, identified as Damien Derek **SOTO**, also fled on foot before being detained. Officers determined **SOTO** had refused to allow two occupants inside vehicle out during the encounter. No injuries were reported. Following the investigation, both accused were arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On March 15 at 8:57PM, officers responded to the area of Dale Blvd. near Minnieville Rd. in Woodbridge (22193) to investigate a crash. The investigation revealed one of the drivers involved, identified as the accused, left the area prior to officers arriving on the scene. A short time later, the accused was located on Austin Ct. where officers determined he was intoxicated. When officers attempted to detain the accused, he actively resisted and pushed an officer before being detained without further incident. No injuries were reported in the crash or subsequent arrest. Following the investigation, the accused, identified as Nelvin **VELASQUEZ-MALDONADO**, was arrested.
