Malicious Wounding *ADDITIONAL ARREST – On March 14, 2025, the suspect sought in connection to the assault that was reported to have occurred at the Columbus Grill located at 8349 Centreville Rd. in Manassas (20111) on November 28, 2024, was arrested. The accused, identified as Eric Yovany **MELARA**, was arrested by the Town of Vienna police. An additional suspect was previously arrested in January in connection with the investigation.

Malicious Wounding *ARREST [Previously Released] – On January 27, 2025, one of the suspects sought in connection to the assault that was reported to have occurred at the Columbus Grill located at 8349 Centreville Rd. in Manassas (20111) on November 28, 2024, was arrested. The suspect, identified as Christopher Osbaldo **AGUIRRE-ARGUETA**, was apprehended by Fauquier County deputies. The second suspect, identified as Eric Yovany **MELARA**, remains wanted.

Malicious Wounding [Previously Released] – On November 28 at 3:04AM, officers responded to Columbus Grill located at 8349 Centreville Rd. in Manassas (20111) to investigate an assault. The investigation revealed the victim, a 27-year-old man, and two acquaintances, identified as the two accused, were involved in a verbal altercation that escalated in the parking lot. During the encounter, both the accused struck the victim causing him to fall to the ground where the men continued to strike and kick the victim. At one point, one of the men through an unknown object at the victim before the two suspects left in a black Toyota pickup truck. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the two accused, identified as Christopher Osbaldo **AGUIRRE-ARGUETA** and Eric Yovany **MELARA**. Attempts to locate either man have been unsuccessful.

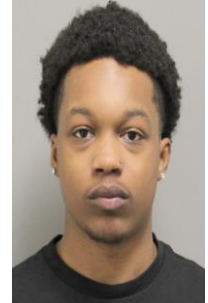

Commercial Burglary – On March 13 at 1:38PM, officers responded to investigate a burglary that was reported to have occurred at Jersey Mikes located at 3282 Old Bridge Rd. in Woodbridge (22192) on March 12 at approximately 10:15PM. The investigation revealed the accused entered the business through an unsecured rear door and took money from the cash register before leaving. Following the investigation, officers obtained arrest warrants for the accused, identified as Tyjaun Cattrell **SMITH**. Attempts to locate the accused have been unsuccessful.

Contributing to the Delinquency of a Minor – On March 13, officers concluded an investigation into a child being reportedly unsupervised at a residence located in the 10500 block of Andrew Humphreys Ct. in Bristow (20136) for several days. The investigation revealed on March 3, school officials attempted to contact the guardians of the victim, a 12-year-old boy. After learning the parents, identified as the two accused, were reportedly out of town, school officials notified the School Resource Officer (SRO). During the investigation, the SRO learned the victim had reportedly been unsupervised at the residence from February 27 until police being notified on March 3. The victim was uninjured and released to the custody of Child Protective Services. Following the investigation, both accused were charged.
