Malicious Wounding [Previously Released] – On August 5 at 4:33AM, officers responded to the Bayvue Apartments located in the 1400 block of Bayside Ave. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 25-year-old man, and another man, identified as the accused, were involved in a physical altercation. During the encounter, the accused possessed a chain saw and struck the victim before another occupant of the residence intervened and separated the parties. The accused was known to the occupants of the apartment and fled prior to police arriving in the area. The victim reported minor injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Maynor Noe SANCHEZ PEREZ. Attempts to locate the accused have been unsuccessful.

Felony Hit & Run Crash Investigation – On March 18 at 7:24AM, officers responded to the area of Yorkshire Ln. near Old Centreville Rd. in Manassas (20111) to investigate a multi-vehicle crash. Prior to the police arriving at the scene, the driver of the striking vehicle, later identified as the accused, left the area on foot. The investigation revealed the accused side-swiped a vehicle before striking another vehicle head-on. A 48-year-old woman driving the other vehicle was treated at an area hospital for non-life threatening injuries.
