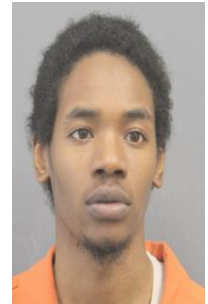
Strangulation | Brandishing a Firearm (Domestic) *ARREST – On March 20, 2025, the suspect, identified as Anthony Jermone **HARVEY**, who was sought in connection to the domestic that was reported to have occurred in the 12400 block of Manchester Way in Woodbridge (22192) on October 13, 2024, was arrested.

Strangulation | Brandishing a Firearm (Domestic) [Previously Released] – On October 14 at 9:50PM, officers responded to investigate a domestic that was reported to have occurred at a residence located in the 12400 block of Manchester Way in Woodbridge (22192) on October 13. The investigation revealed the victim, a 24-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused pointed a firearm at the victim before placing his hands around her neck. The accused also struck the victim before the parties eventually separated. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Anthony Jermone **HARVEY**. Attempts to locate the accused were unsuccessful.

Commercial Burglary – On March 20 at 12:53AM, officers responded to investigate a burglary that was reported to have occurred at a business center located at 3320 Noble Pond Way in Woodbridge (22193) on March 19. The investigation revealed sometime between 4:30AM-8:00AM entry was made into the building through an unsecured door. A microwave was reported missing.

Vandalism on School Grounds – On March 19 at 7:57AM, the School Resource Officer assigned to Ronald Reagan Middle School located at 15801 Tanning House Pl. in Haymarket (20169) was notified of a vandalism in the bathroom. The investigation revealed a swastika and derogatory language were drawn on a bathroom stall. The drawings did not appear to contain any threats towards students or staff. No additional markings were reported.

Malicious Wounding [Domestic] – On March 19 at 6:53PM, officers responded to a residence located in the 7400 block of Barbados Ln. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 43-year-old man, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused physically prevented the victim from leaving before stabbing him multiple times. The parties eventually separated, and the police were contacted. The victim was transported to an area hospital with non-life threatening injuries. Following the investigation, the accused, identified as Jasmin Janet **LUCERO**, was arrested.

Strangulation [Domestic] – On March 19 at 11:30PM, officers responded to the Rolling Brook Apartments located in the 1700 block of Shady River Ct. in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 36-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and wrapped his arm around her neck before the parties separated. The victim reported non-life threatening injuries. Following the investigation, the accused, identified as Kevin Michael **SWEENEY**, was arrested.
