Burglary of a School *ARREST – Detectives identified and arrested a suspect sought in connection to a burglary that was reported to have occurred at Yorkshire Elementary School located at 7610 Old Centreville Rd. in Manassas (20111) on August 15, 2023. During the investigation, detectives obtained additional information identifying the suspect as Ivan **REYES URBINA**, and on March 20, 2025, following the investigation, he was served while incarcerated at the Adult Detention Center for unrelated charges.

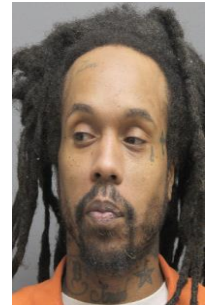
Incidents

Fatal Hit & Run Crash Investigation – On March 20 at 9:03PM, officers responded to the area of Richmond Hwy. near Easy St. in Woodbridge (22191) to investigate an unconscious man in the roadway. The investigation revealed the driver of a 2012 Toyota Highlander was traveling southbound on Richmond Hwy. when the vehicle struck a pedestrian who was attempting to cross Richmond Hwy. outside of a crosswalk. The pedestrian was then struck by a separate unknown vehicle that was also traveling southbound on Richmond Hwy. The pedestrian was transported to an area hospital where he died from injuries sustained in the collisions. The driver of the Toyota remained at the scene and was uninjured. No further information on the unknown driver or striking vehicle is available at this time. **Investigators with the Crash Investigation Unit are asking anyone who may have witnessed this crash to contact police.** The investigation continues.

Malicious Wounding | Armed Robbery – On March 20 at 9:28PM, officers responded to the Regency Apartments located in the 9900 block of Gardenia Ln. in Manassas (20109) to investigate a stabbing. The investigation revealed the victim, a 38-year-old woman, was lured to the above address by an acquaintance, identified as the accused. While inside the apartment, the accused and a female acquaintance, assaulted the victim, cut her with a razor and took her money before leaving. The victim was transported to an area hospital with non-life threatening injuries. Following the investigation, officers obtained warrants for the accused, identified as Devin Edward **THOMPSON**. The investigation continues as officers attempt to identify the female suspect and locate the **THOMPSON** suspect.

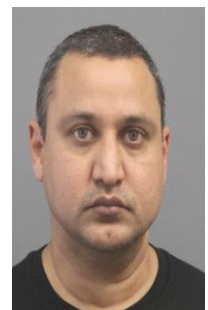

Vandalism on School Grounds – On March 20 at 12:36PM, the School Resource Officer (SRO) assigned to Unity Braxton Middle School located at 10100 Lomond Dr. in Manassas (20109) was notified of vandalism in the bathroom. The investigation revealed derogatory language was drawn on a bathroom wall. On March 21, the SRO was notified of an additional vandalism of a similar style in a separate bathroom. Both writings were recently observed and reported to school personnel; neither appeared to contain any threats toward students or staff. No additional markings were reported.

Arrests

Sexual Assault Investigation – On March 19, 2025, detectives concluded an investigation into a sexual assault that was reported to have occurred at Gainesville Pharmacy located at 7963 Heritage Village Plz. in Gainesville (20155) on January 23, 2021. The investigation revealed the victim, who was an adult at the time of the offense, went to the pharmacy near closing time and while inside the business, the owner closed the store before pulling the victim into a room and sexually assaulting her. The parties eventually separated, and the victim left the business. The victim recently reported the incident prompting the investigation. Following the investigation, the accused, identified as Davinder Pal **KAHLON**, turned himself in to police.

Attempted Malicious Wounding [Domestic] – On March 20 at 12:12PM, officers responded to a residence located in the 14200 block of Essex Dr. in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 46-year-old man, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the physical altercation, the accused grabbed a knife and attempted to stab the victim before the parties were separated. The victim reported non-life threatening injuries. Following the investigation, the accused, identified as a **17-year-old male juvenile**, was arrested.

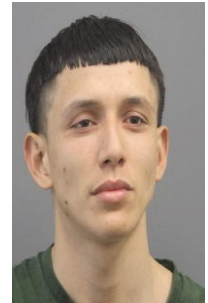

Assault & Battery on a Law Enforcement Officer [LEO] – On March 21 at 12:24AM, while officers were investigating a crash in the area of Rippon Blvd. and Forest Grove Dr. in Woodbridge (22191) one of the involved parties, later identified as the accused, attempted to leave the area. When officers attempted to detain the accused, he pushed an officer before being detained without further incident. No injuries were reported. Assault & Battery – On March 14, the School Resource Officer (SRO) assigned to Osbourn Park High School located at 8909 Euclid Ave. in Manassas (20111) began an investigation into an assault involving a teacher on a student that was reported to have occurred on March 12. The investigation revealed the victim, a 15-year-old female student, approached a teacher at the school, identified as the accused, during class. During the encounter, the accused grabbed the victim by the back of the neck and pushed her forward before the parties separated. No injuries were noted during the investigation.
