Incidents

Armed Robbery – On March 22 at 10:09PM, officers responded to the Riverside Station Apartments located in the 14000 block of Big Crest Ln. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 14-year-old male juvenile, arranged to exchange clothing items with an unknown individual via Instagram. The victim was approached by two unknown young males, possibly juveniles. During the encounter, the suspect wearing a face mask brandished a firearm before both suspects took the victim's clothing and left the area. While checking the area, officers located one of the clothing items nearby. No injuries were reported. The suspects were described as black males wearing dark-colored clothing.

Strong-Arm Robbery – On March 21 at 7:18PM, officers responded to the Macy's inside Manassas Mall located at 8270 Sudley Rd. in Manassas (20109) to investigate a robbery. The investigation revealed employees confronted an unknown man for concealing merchandise. During the encounter, the man pushed two adult employees before leaving the store with the unpaid merchandise. No injuries were reported. The suspect was described as a black with dreadlocks wearing a red hooded sweatshirt, blue jeans and white sneakers.

Arrests

Malicious Wounding – On March 24 at 3:10AM, officers responded to the 7500 block of Belle Grae Dr. in Manassas (20109) to investigate a shooting. The investigation revealed the victim, a 31-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated when the accused brandished a firearm. When the victim attempted to leave the area, the accused fired a round striking the victim. The victim continued out of the area and contacted the police. The victim was transported to an area hospital with non-life threatening injuries. While investigating the incident, officers located a shell casing and other evidence in the above area. Following the investigation, detectives obtained arrest warrants for the accused, identified as Adrian **GARCIA**, who was later located at his residence and taken into custody without incident.

Attempted Malicious Wounding [Domestic] – On March 22 at 9:24PM, officers responded to a residence located in the 10400 block of Rapidan Ln. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the accused was involved in a verbal altercation with multiple family members that escalated. During the encounter, the accused struck a 60-year-old female family member, before retrieving a knife and attempting to stab the victim and two other adult family members. The parties eventually separated, and the victims left the residence. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Abir **THAKUR**, who was taken into custody the following morning.

Assault & Battery on a Law Enforcement Officer [LEO] – On March 22 at 10:00PM, officers responded to a residence located in the 7500 block of Duneiden Ln. in Manassas (20109) for a person in crisis. While investigating the incident, the accused pushed an officer before walking out of the residence. When officers attempted to detain the accused, she actively resisted and grabbed an officer. The accused was eventually detained without further incident. Minor injuries were reported by the officers. Following the investigation, the accused, identified as Joahнна Lauren **ALIZAI**, was arrested.



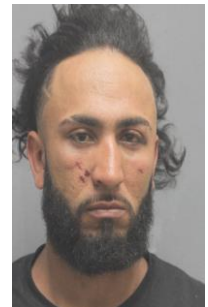

Residential Burglary – On March 22 at 4:30AM, officers responded to a residence located in the 8000 block of Portwood Turn in Manassas (20109) to investigate a burglary. The investigation revealed the homeowner heard noises in the backyard and upon checking, observed an unknown man, later identified as the accused, leaving the backyard with property from the victim's shed. The victim followed the accused and during the ensuing brief struggle, the accused struck the victim before police arrived and detained the accused. The victim reported non-life threatening injuries, and his toolbox and other property were recovered. Following the investigation, the accused, identified as Byron **ARGUETA ARGUETA**, was arrested.
