Malicious Wounding [Domestic] - On March 26 at 11:36PM, officers responded to the Riverside Station Apartments located in the 14000 block of Big Crest Ln. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 28-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck and kicked the victim multiple times before physically preventing her from leaving the residence. The accused took the victim's money and phone before leaving the apartment. The victim was treated at an area hospital for non-life threatening injuries. Officers and a police K-9 searched the area for the accused who was not located. Following the investigation, officers obtained arrest warrants for the accused, identified as Elisha Herbert **WILLIAMS.** Further attempts to locate the accused have been unsuccessful.
