### **Arrests**

**Sexual Assault Investigation –** On March 27, detectives concluded an investigation into a series of sexual assaults that were reported to have occurred at residences located in the Woodbridge (22191) area of Prince William County spanning approximately 11 years between 2012 and 2023. The investigation revealed two female victims, who were both young children when the assaults began, were sexually abused by three known parties, identified as the accused, on multiple occasions during that timeframe. The allegations were recently reported to the police in January 2025 launching the investigation. Over the course of two months, the suspects were identified and located. Following the investigation, all three men, identified on the next page, were arrested between March 20-27.

**Felony Child Neglect** – On March 26, detectives began an investigation into a child neglect stemming from an incident that occurred at a residence located in the Manassas (20111) area of Prince William County on March 15. The investigation revealed the victim, a female child under the age of 12, was physically disciplined by her father using a bamboo stick. During the encounter, the victim attempted to block a strike, which injured her arm. Over the course of several days following the incident, the victim complained of severe pain to her arm to both parents. Approximately nine days later, the victim was seen at a medical facility where her arm was determined to be fractured. Following the investigation, the accused, identified below, were charged.
