

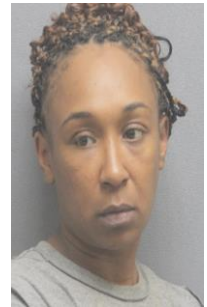


## DAILY INCIDENT REPORT

### Updates

**Malicious Wounding | Armed Robbery \*ARREST** – After further investigation into the malicious wounding that was reported to have occurred at the Regency Apartments located in the 9900 block of Gardenia Ln. in Manassas (20109) on March 20, officers identified and obtained charges against the female acquaintance involved in the assault. On March 23, following that investigation, the female suspect, identified as Malkia Dannelle **ALEXANDER**, was arrested. On March 29, the male suspect, identified as Devin Edward **THOMPSON**, who was previously sought in connection to the malicious wounding was also arrested.

**Malicious Wounding | Armed Robbery [Previously Released]** – On March 20 at 9:28PM, officers responded to the Regency Apartments located in the 9900 block of Gardenia Ln. in Manassas (20109) to investigate a stabbing. The investigation revealed the victim, a 38-year-old woman, was lured to the above address by an acquaintance, identified as the accused. While inside the apartment, the accused and a female acquaintance, assaulted the victim, cut her with a razor and took her money before leaving. The victim was transported to an area hospital with non-life threatening injuries. Following the investigation, officers obtained warrants for the accused, identified as Devin Edward **THOMPSON**. The investigation continues as officers attempt to identify the female suspect and locate the **THOMPSON** suspect.

## Incidents

**Strangulation [Domestic]** – On March 31 at 3:36AM, officers responded to investigate a domestic dispute that was reported to have occurred at a residence located in the 7900 Deward Ct. in Manassas (20109) on March 30 at approximately 9:00PM. The investigation revealed the victim, a 61-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim's neck and then struck her multiple times before the parties separated. The victim was treated at an area hospital for non-life threatening injuries where police were contacted. Following the investigation, officers obtained arrest warrants for the accused, identified as Otis Lee **ALLEN**. Attempts to locate the accused have been unsuccessful.

**Brandishing of a Firearm [Road Rage Related]** – On March 28 at 4:08PM, officers responded to the intersection of Opitz Blvd. and Gideon Dr. in Woodbridge (22191) to investigate a brandishing. The investigation revealed the victim, a 36-year-old man, and the driver of another vehicle, identified as the accused, were involved in a road rage incident. While both drivers were stopped at the above intersection, the accused brandished a firearm towards the victim before the parties separated. No shots were fired, and no injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Marshad D. **LEDBETTER**. Attempts to locate the accused have been unsuccessful.

## Arrests

**Reckless Handling of a Firearm** – On March 31 at 8:55PM, officers responded to The Crossings at Summerland Apartments located in the 13700 block of Keelingwood Cl. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed the accused fired multiple rounds into the air after a verbal altercation with an acquaintance. Officers located the accused inside her vehicle where she was detained without incident. No injuries or property damage were reported. The firearm was recovered. Following the investigation, the accused, identified as Tyra **TEDDER**, was arrested.
