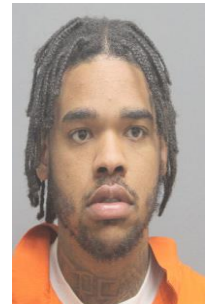

### Updates

**Malicious Wounding [Domestic]** – On April 1, the suspect, identified as Elisha Herbert **WILLIAMS**, who was sought in connection to the malicious wounding that was reported to have occurred at the Riverside Station Apartments located in the 14000 block of Big Crest Ln. in Woodbridge (22191) on March 26, was arrested.

**Malicious Wounding [Domestic] [Previously Released]** – On March 26 at 11:36PM, officers responded to the Riverside Station Apartments located in the 14000 block of Big Crest Ln. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 28-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck and kicked the victim multiple times before physically preventing her from leaving the residence. The accused took the victim's money and phone before leaving the apartment. The victim was treated at an area hospital for non-life threatening injuries. Officers and a police K-9 searched the area for the accused who was not located. Following the investigation, officers obtained arrest warrants for the accused, identified as Elisha Herbert **WILLIAMS**. Further attempts to locate the accused have been unsuccessful.

**Malicious Wounding [Previously Released]** – On November 7 at 2:34AM, officers responded to a residence located in the 13200 block of Haddock Rd. in Woodbridge (22193) to investigate an assault. The investigation revealed the victim, a 57-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused pushed the victim before striking her in the face with a stone object. The parties separated and the accused left the residence. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Asha Yussef **MOHAMED**. Attempts to locate the accused have been unsuccessful.

## Incidents

**Shooting Investigation** – On April 2 at 3:43PM, officers responded to the area of Dumfries Rd. near Walton Dr. in Manassas (20112) to investigate a shooting. The investigation revealed the victim, a 36-year-old man, was traveling northbound on Dumfries Rd. when a road rage incident ensued with the driver of another vehicle. As both vehicles stopped at the above intersection, a verbal altercation escalated and the other driver fired multiple rounds, striking the victim and his vehicle before the parties separated. The victim drove to an area hospital where police were contacted. Non-life threatening injuries were reported. No additional injuries or property damage were reported. The suspect's vehicle was described as a light-colored sedan occupied by two unknown individuals.

**Armed Robbery** – On April 2 at 7:25PM, officers responded to the 3600 block of Golf Side Circle, in Woodbridge (22192) for a report of a robbery. The investigation revealed a food delivery driver was threatened and robbed by an unknown man and woman. During the encounter, the male suspect implied he was armed before taking the food and leaving the area with the female suspect. The victim also left the area and reported the incident to the police. No injuries were reported. Officers searched the area for the suspects who were not located.

***Suspect Descriptions:***

Black male, early 20s, approximately 5'8-5'9, with short dreadlocks

Last seen wearing a dark-colored sweatshirt and sweatpants

Black female, about 18 years old, approximately 5'4, 145 lbs., with dreadlocks

No clothing description

**Threats to Bomb** – On April 2 at 9:56AM, officers responded to Covington Harper Elementary School located at 2500 River Heritage Blvd. in Dumfries (22026) to investigate a phone threat. The investigation revealed a woman, later identified as the accused, contacted the school and made threats. School personnel contacted the police who identified the accused and determined she was not in the immediate area. There was no active threat to the school, students, or staff. Following the investigation, officers obtained arrest warrants for the accused, identified as Nidera **FORTUNE**. Attempts to locate the accused have been unsuccessful.
