Incidents

Shooting Investigation – On April 3 at 3:29PM, officers responded to the Woodbridge Station Apartments located in the 1500 block of Constellation Pl in Woodbridge (22191) to investigate a shooting. The investigation revealed the victim, a 29-year-old man, and an unknown man were involved in an altercation. During the encounter, the victim was shot. The parties dispersed prior to officers arriving on the scene. The victim went to an area hospital where police were contacted. The victim sustained life-threatening injuries and remains hospitalized. At this time, it is unknown what led up to the shooting. The suspect was not located and only described as a light-skinned black male wearing a dark-colored hooded sweatshirt.

Strong-Armed Robbery – On April 3 at 6:46PM, officers responded to investigate a robbery which was reported to have occurred at the Mapledale Plz located in the 5400 block of Mapledale Plz in Woodbridge (22193) earlier that afternoon at approximately 4:00PM. The investigation revealed the victim, a 35-year-old man, was behind the shopping center when he was approached and robbed by three unknown men. The suspects assaulted the victim before taking his cigarettes and leaving the area. Minor injuries were reported. The suspects were only described as two black males and one Hispanic male.

Residential Burglary – On April 3 at 3:27PM, officers responded to a residence located in the 18500 block of Colby St in Triangle (22172) to investigate a burglary. The investigation revealed sometime between 11:00AM and 3:20PM, entry was made into the home, possibly through an unsecured rear door. There were no signs of forced entry. An undisclosed amount of money was reported missing.

Arrests

Strangulation [Domestic] – On April 1 at 11:30AM, officers began an investigation into a domestic assault that was reported to have occurred at a residence located in the 15100 block of Toccoa Ct in Gainesville (20155) on March 27. The investigation revealed the victim, a 26-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim multiple times before choking her. The parties separated and the accused left the home. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as James **TAHIYAT**, who was later arrested on April 4.

Strangulation – On April 2 at 10:15PM, officers responded to Life Time located at 7801 Limestone Dr in Gainesville (20155) to investigate an assault. The investigation revealed the victim, a 17-year-old male juvenile, and an unknown man, later identified as the accused, were playing basketball at the location when an altercation ensued. During the encounter, the accused pushed the victim to the ground before putting him in a chokehold. The parties separated and the accused left the area prior to officers arriving on scene. Minor injuries were reported. Officers later located and detained the accused without further incident. Following the investigation, the accused, identified as Andre Nygel **JOSPEH**, was arrested.

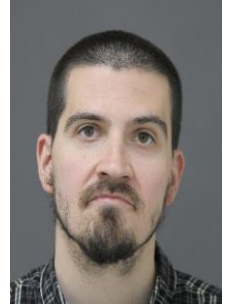

Attempted Malicious Wounding – On April 3 at 10:00AM, officers responded to the area of Randolph Ridge Ln and Hansen Farm Rd in Manassas (20109) to investigate a dispute. The investigation revealed the victim, a 52-year-old man, and an unknown man, later identified as the accused, were involved in a verbal altercation in a parking lot in the above area. The parties briefly separated before engaging in a second altercation nearby where the accused shot the victim with a BB gun. The accused then left the area, hitting the victim's vehicle in the process. Minor injuries were reported. Officers located and detained the accused without further incident. Following the investigation, the accused, identified as Paul Weston **RENFRO**, was arrested.
