

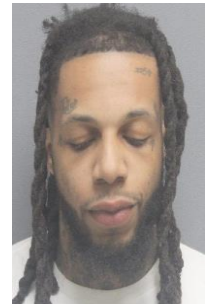

Updates

Strangulation [Domestic] *ARREST – On April 10, the suspect, identified as Jordan Alan **LOCKETT**, who was sought in connection to the domestic dispute that was reported to have occurred in the 10100 block of Asheville St. in Manassas (20109) on April 7, was arrested.



Arrested on April 10:

Strangulation [Domestic] [Previously Released] – On April 7 at 9:02PM, officers responded to investigate a domestic dispute that was reported to have occurred in the 10100 block of Asheville St. in Manassas (20109) earlier that day at approximately 3:45PM. The investigation revealed the victim, a 36-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated in the cul-de-sac of the above location. During the encounter, the accused struck the victim multiple times and grabbed her neck. When the victim attempted to contact emergency services, the accused temporarily took her phone and threw her to the ground before leaving. The victim reported non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Jordan Alan **LOCKETT**. Attempts to locate the accused have been unsuccessful.

Incidents

Residential Burglary – On April 10 at 7:20PM, officers responded to the Somerset Pointe Apartments located in the 14700 block of Soapstone Dr. in Gainesville (20155) to investigate a burglary. The investigation revealed sometime between April 7 and April 10, forced entry was made into the apartment through a window that was found damaged. No property was reported missing.

Residential Burglary – On April 10 at 10:31AM, officers responded to investigate a burglary that was reported to have occurred at a residence located in the 15200 block of Golf View Dr. in Haymarket (20169) on April 7 between 1:30PM and 4:30PM. The investigation revealed entry was made into the home through an unsecured door. An undisclosed amount of money was reported missing.

Arrests

Attempted Malicious Wounding on a Law Enforcement Officer [LEO] – On April 10 at 3:47AM, officers responded to the Orchard Mills Apartments located in the 3300 block of Bronson Ct. in Woodbridge (22193) to investigate a vehicle tampering. While officers were checking the parking lot, the driver of a vehicle, later identified as the accused, accelerated and struck the officer's vehicle before fleeing the parking lot. Officers pursued the vehicle onto Benita Fitzgerald Dr. where the vehicle crossed over Dale Blvd. and left the roadway before coming to a stop near a wooded area. The accused was detained without further incident while a passenger fled on foot. Officers, a police K-9, and Fairfax police helicopter searched for the passenger who was not located. No injuries were reported. While investigating the incident, officers determined the vehicle was stolen. Following the investigation, the accused, identified as a **17-year-old male juvenile**, was arrested. The investigation continues as detectives attempt to identify the unknown passenger.

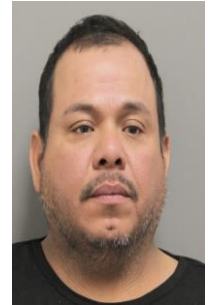

Arrests, *continued*

Rape Investigation – On April 6, detectives began an investigation into a sexual assault that was reported to have occurred at a residence located in the 12300 block of Oakwood Dr. in Woodbridge (22192) on March 30. The investigation revealed the victim, who was under the age of 15, was at the above residence when an acquaintance, identified as the accused, provided her with alcohol and marijuana. At one point during the evening, the victim became incapacitated and was sexually assaulted by the accused. The victim went to an area hospital where the police were contacted. Following the investigation, the accused, identified as Gerson Leonel **ESTRADA RODRIGUEZ**, was arrested.

Strong-Arm Robbery – On April 10, 2025, officers concluded an investigation into a robbery that was reported to have occurred in the area of Darbydale Ave. and Westminster Ln. in Woodbridge (22193) on December 11, 2024. The investigation revealed the victim, a 19-year-old man, arranged to sell shoes via Facebook Marketplace to an unknown man, later identified as the accused. Before the sale was completed, the accused grabbed the shoes, and a struggle ensued before the accused left with one of the shoes and a hat. No injuries were reported. While investigating the incident, officers identified the accused and obtained warrants for his arrest. On April 10, officers in the Woodbridge area located and arrested the accused, identified as Mohamed L **SWARAY**.
